THOSE LEADERS REPORTED THAT THEY TRAINED 887 NATIONAL ORGANIZATIONS AND CHURCHES AND 8,378 LEADERS IN 70+ COUNTRIES. 16 OF THESE ORGANIZATIONS, IN A SAMPLE SURVEY, REPORTED USING OUR PROGRAMMING TO REACH 3,006 FAMILIES AND 224,755 CHILDREN WITH ONE OR MORE INTERVENTION OR PREVENTION STRATEGIES AND/OR PROGRAMS IN THE WVO ROADMAP.
